## MEDIA ACCREDITATION GUIDELINES

The following guidelines are provided to facilitate access to the World Junior Squash Championships 2017 ("WJC") and its participants while also providing all the tools and assistance to enable the best possible media coverage of this exciting event.

We recognise that media have needs that are vital to effective coverage of the event, and we acknowledge the rights and responsibilities of bona fide media representatives as they cover and report on these events. We know also that news organisations will understand the need for WJC to have the following policies and procedures in place for media who are attending and covering the WJC event.

Accreditation is granted with the provision that applicants agree to and abide with the event Accreditation Terms and Conditions.

*Accreditation is granted subject to the applicant complying with the following Terms & Conditions:*

1. That submission of an application form does not guarantee the granting of Accreditation or access to the Venues, however accreditation will not be unreasonably withheld;
2. That accreditation may be revoked for any behaviour not in the best interests of the Event or in breach of the Terms and Conditions;
3. To abide by Health & Safety regulations at each Venue. The applicant shall move in and around the Venue at his/her own risk.
4. To abide by all reasonable directions and terms of entry issued by or on behalf of the WJC management whilst at the event, including (but not limited to) places and times of access to the Venues or areas within the Venues;
5. To acknowledge that any accreditation granted to the applicant is specific to individual person and/or media outlet and may not be loaned or transferred to any other person;
6. To abide by and comply with the policy whereby all interviews with athletes and special guests will take place during the designated press events and/or allocated times and absolutely no other time, unless previously arranged and approved through the Media Manager;
7. To ensure that at all times whilst attending the Event:
  - a) to wear the Media identifying pass ("Accreditation Pass") and ensure such pass is visible at all times;
  - b) not to prejudice or infringe the copyright or other intellectual property or proprietary interests owned by, or licensed to, any person officially involved in the staging of the event;
  - c) to conduct himself/herself and act generally in a manner that will not bring the WJC or squash into disrepute;
  - d) to use professional courtesy and conduct himself/herself in a manner that will not cause offence to, or otherwise inhibit the enjoyment of, all other parties in attendance at the Event;
  - e) to not interfere with other media, spectators, rights holders, athletes, teams at any time during the Event.
8. Access to a Venue will be refused to any person noticeably under the influence of alcohol, narcotics or any behaviour-modifying substance, or to any person behaving or likely to behave violently, harmfully or in a manner contrary to public order;
9. WJC reserves the right to make alterations to the time, date and place of Matches due to unforeseen circumstances;
10. WJC reserves the right to appoint official photographers for any Match. Such photographers shall be granted preferential rights in respect of positioning.

Nothing in these Accreditation Terms and Conditions is intended to be, or shall be, interpreted as undermining editorial independence or as restricting or preventing the reasonable exercise of normal journalistic activities, including expressions of comment and fair criticism.
